The *delegatus non potet delegare* principle created by international arbitrators in the context of mediation, arbmed and med-arb

Do arbitrators have the power (or duty) to suggest to parties to mediate in the absence of step-up dispute resolution clauses in the contract? This panel will describe, analyse and criticise the principle created by international arbitrators that the arbitrator's duty is to proceed to an award, and has neither power nor duty to stay arbitration to refer the matter to mediation. In particular, it will address:

- Does the arbitrator have the power to stay proceedings to enable mediation to take place where one party so applies or where the tribunal considers it just and reasonable to do so?
- Can the arbitrator impose cost sanctions on a party who fails to engage or refuses to mediate?
- Does the arbitral tribunal have a duty to order a stay where the interests of justice clearly point in that direction?
- What is the future of *delegatus non potet delegare* in the rapidly changing landscape of dispute resolution, in an ad hoc arbitration and in institutional arbitrations?
